I am working on sorting an array using qsort() function in C. The idea is sorting sub-arrays in the main array based on some criteria. However, the data is in the form of numbers separated by commas in a text file. For example: 12,13,20,44,89,6,20,45,6,33,9,50,39,3 The data in each sub array is a number separated by commas. But I need to sort the array in such a way that the data in each sub array is sorted based on the numbers that are within the brackets. For example, the above data will be sorted as: 12,13,20,20,20,20,44,44,44,89,89,89,6,6,6,6,6,6,6,6,6,9,9 ,9,9,50,50,50,50,50,50,50 How can I sort it? Please feel free to suggest a better design to solve this problem. A: C uses descending order for numbers (its beginning to get some of the features of the default lexicographical sorting from C++). ASCII codes 0 through 9 are between a and b,

10 through 99 are between b and c, and 100 and above are between c and d. So, you want a sort that puts each substring ending in a digit in aa, bb, cc, and dd, aa, ab, ac, ad and so on, where aa is the highest (an ascending sort, so, upper case), and dd is the lowest (a descending sort, so, lower case). As noted previously, the Act is a special statutory procedure by which a claimant may obtain certain of his or her rights and privileges against a governmental entity, including immunity from suit. IND. CODE § 34-4-16.5-1 et seq. Among those rights and privileges that are available to claimants is the right to bring a cause of action against a governmental entity. However, even this limited authority is subject to certain conditions and limitations. IND. CODE § 34-4-16.5-3.[3] Among those conditions that are mentioned in that provision is the condition that the claim against the governmental entity must be filed within the applicable statute of limitations. IND. CODE § 34-4-16.5-3. Such limitations are not absolute and include exceptions. IND.

CODE § 34-4-16.5-3; see also IND. CODE § 34-4-16.5-2(1) (defining "claimant"). The Act's limitations were designed to protect the government from stale or fraudulent claims. Jackson v. Indianapolis Power & Light Co., 644 N.E.2d 1353, 1355 (Ind.Ct.App.1994), trans. denied. As this court explained in Smith v. U.S., 567 N.E.2d 16 (Ind.Ct.App.1991), trans. denied, our supreme court recognized as much in Rollin v. State, 721 N.E.2d 1285, 1290 (Ind.1999). In Rollin, the court considered whether a claim that a mentally retarded person was not given proper treatment for injuries allegedly caused by the treatment he received had been filed within the applicable statute of limitations and concluded it was not. The court began its analysis by acknowledging that the question was one of first impression and that the relationship between the Act and the general statute of limitations was not clear. Id.
